As required by the Form 28 and Form 15 COAs, attached is the secondary containment information (SPCC plan) and the diagram for the water withdrawal station. The withdrawal station consists of a 10" poly pipe that's anchored to a cement block near the edge of the pit, is run from there down the pit sidewall, and terminates near the bottom of the pit (see the attached diagram). The poly pipe is slightly elevated off the pit liner to prevent abrasion of the liner. This is accomplished through the use of rubber mats and a support cribs along the length of the pipe.
