Comment: **Location does not meet reclamation requirements; insufficient vegetative cover/ vegetation has not achieved uniform distribution. Transects were conducted indicating vegetation is not 80% of the surrounding reference area. SEE ATTACHED**

Corrective Action:	Reclaim location and area of the pit in accordance to COGCC reclamation regulations and establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of pre-disturbance or reference area levels. Use a seed mixture that matches the adjacent pastureland or a seed mixture requested by the landowner. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until Final Reclamation has passed.
