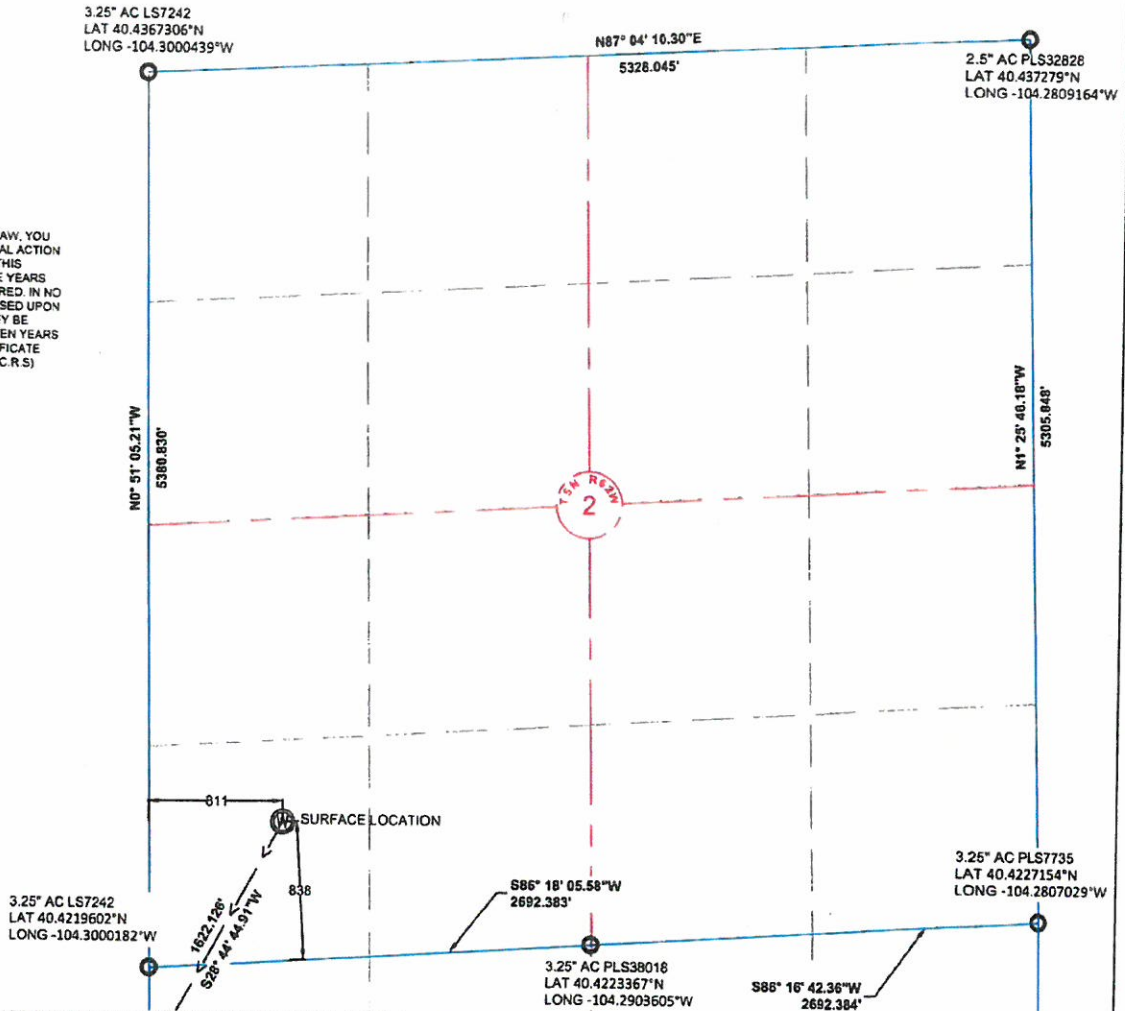

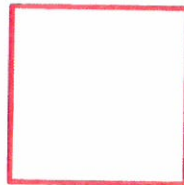

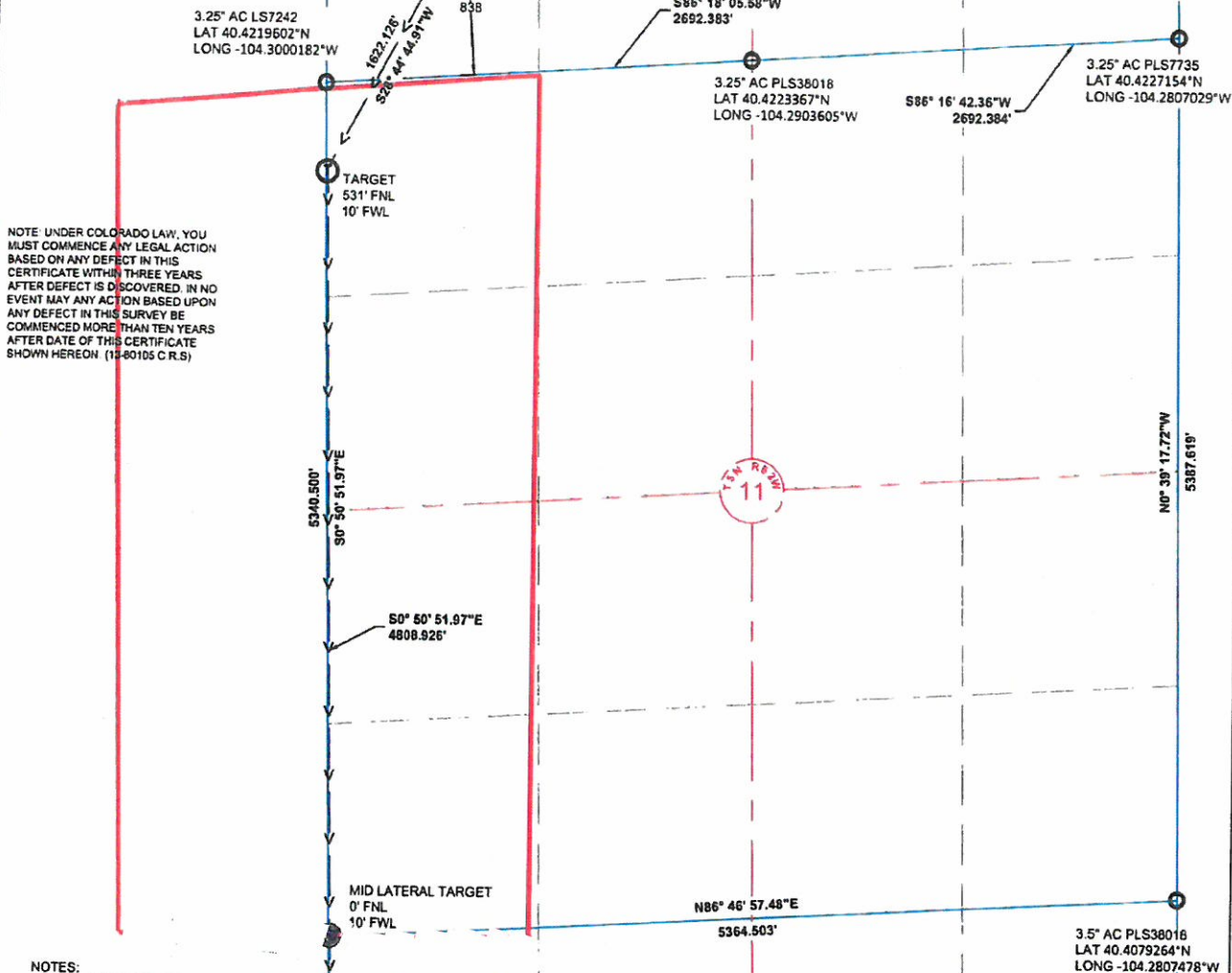
Wellbore Spacing Unit Outline

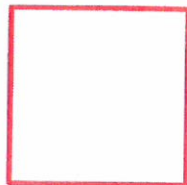

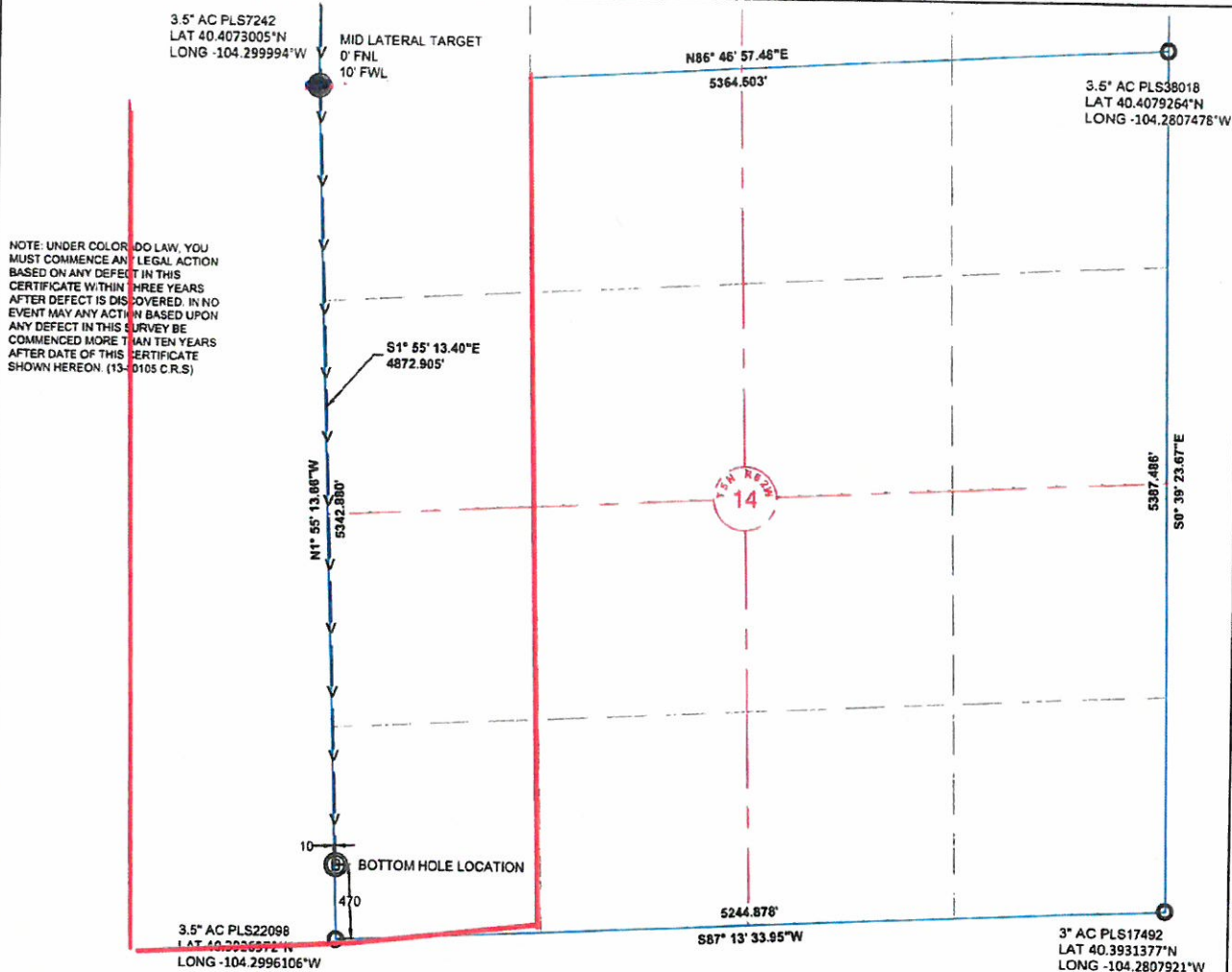
Wellbore Spacing Unit Outline



Wellbore Spacing Unit Map

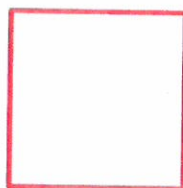
