DOUBLE BAR O DOUBLE BAR, INC., 4150 East Mexico, Suite No. 3, Denver, Colorado, hereinafter called "Grantor", for and in consideration of \$10.00 and other good and valuable consideration in hand paid by UNION OIL COMPANY OF CALIFORNIA, 1860 Lincoln Street, Denver, Colorado 80202, hereinafter called "Grantee", receipt and sufficiency of which is hereby acknowledged, does hereby grant and convey unto Grantee, its successors and assigns, the following-described land, situated in Adams County, Colorado, to-wit:

All that portion of the East 1/2 of the Southeast 1/4 of Section 18, Township 1 South, Range 60 West, of the 6th P.M., Adams County, Colorado, described as follows:

Beginning at the Southeast Corner of the Southeast 1/4 of said Section 18; thence North 1,406 feet along the East line of said Southeast 1/4 to the true point of beginning; thence West 208.71 feet parallel to the South line of said Southeast 1/4 of said Section 18; thence South 208.71 feet parallel to the East line of said Southeast 1/4 of said Section 18; thence East 208.71 feet parallel to the South line of said Southeast 1/4 of said Section 18; thence North 208.71 feet to the true point of beginning, containing 1.00 acre, more or less.

To have and to hold the above-described premises unto Grantee forever; provided, however, that in the event Grantee, its successors and assigns, shall by its sole election abandon said land for the use of a compressor site, then in such event the above-described land and all interest therein as conveyed hereby shall revert to Grantor, its successors or assigns. Grantee shall have the continuing right to remove all materials, facilities and equipment placed upon said premises, but Grantee agrees to remove the same within 6 months following abandonment.

It is expressly understood and agreed that said land is now under lease for oil and gas and that this Deed is subject thereto and this Deed conveys no mineral interest under the lands, Grantor specifically excepting and reserving all oil, gas and other minerals.

For aforesaid consideration Grantor hereby grants the right to build and erect such structures on said land as Grantee may require for use and operation of a compressor site, together with full rights of ingress and egress to and from said site.

Grantor warrants and agrees to defend title to the aforesaid lands, and the quiet and peaceful possession thereof, to Grantee, by, through and under Grantor, but not otherwise.

In Witness Whereof, the Grantor has set its hand and seal the 2nd day of April, 1971, same to extend to and be binding upon Grantor, Grantee and their successors and assigns.


