TEP Rocky Mountain LLC respectfully requests to complete the upper half of the Williams Fork Formation (MV4 - MV8) in the Federal RGU 43-1-298 well. Current and proposed wellbore diagrams are attached.

Proposed Procedure:

1. MIRU service rig
2. RIH Tag fill
3. POOH while tallying and Tuboscoping tbg, lay down tbg
4. RIH w/ cast iron kill plug and set at appx 9,502'. Dump bail cement on top of plug
5. Pressure test csg to surface to 9500psi for 15 mins
6. Frac MV 4-MV8
7. Drill out to kill plug circulate clean.
8. RIH with 2 3/8" N-80 tbg and land at appx 9,279'. Flowback stages (drill out at further date)
9. Return well to production
