File electronic Form 42 once abandonment complete.</p> <p>4) Please submit directional survey data with Form 6 Subsequent Report of Abandonment.</p> <p>5) Production casing stub plug is also surface casing shoe plug, this plug must be tagged at 525' or shallower. Leave at least 100' of cement in the wellbore for each plug.</p>
