COMMENTS:

Add one (1) water tank, two (2) separators, two (2) gas or diesel motors, three (3) oil tanks, one (1) flare, and one (1) PDC skid to location. Therefore, the new totals are two (2) water tanks, four (4) separators, two (2) gas or diesel motors, six (6) oil tanks, two (2) flares, and one (1) PDC skid.

One buried pipeline is utilized to gather gas production from the location. The main pipeline is constructed of 3 inch nominal diameter SDR 13.5 HDPC 4710 pipe engineered to handle design pressures. The pipeline originates on location and terminates at a larger mainline off of the pad. One flowline is installed from each wellhead to a separator carrying multiphase flow. During production, the flow is from the wellhead to the production facility. Each buried flowline is a 3 inch schedule 40 steel pipeline and approximately 190 feet in length.

Two (2) lines begin from the separator. The first line from the separator is a gas line routed to the pipeline described above and the second line is a liquid line connected to a treater. The treater then has three (3) lines emanating from it: one line to the flares; one line to the oil production tanks; and one line to the water tanks.

The modification of this existing Oil & gas location was within the originally disturbed area, and there was not additional surface disturbance. In addition, the modification did not change the cultural distances included on the original Form 2A.
