On October 3, 2016, Synergy Resources Corporation met with Troy Swain, Kelly Cannon and Amanda Cannon. After numerous conversations with both Cannon's and consent from the surface owner, Aggregate Industries-WCR, Inc., Synergy has agreed to place 15-20 trees on the west side of the facility after completion/installation of the production facility and wells. In addition to the trees, Synergy plans to place a temporary sound wall around the Operations Area during drilling and completion operations as well as a permanent sound wall around the compressors at the production facility.
