## COMMENTS:

Add six (6) water tanks, one (1) condensate tank, ten (10) separators, two (2) electric motors, two (2) LACT Units, two (2) gas compressors, sixteen (16) oil tanks, two (2) VRU's, two (2) produced water skids, and one (1) PDC skid to the location. Therefore, the new totals are twenty-two (22) water tanks, one (1) condensate tank, eighteen (18) separators, two (2) electric motors, two (2) LACT Units, two (2) gas compressors, thirty-two (32) oil tanks, two (2) VRU's, two (2) produced water skids, and one (1) PDC skid.

The modification of this existing oil & gas location was within the originally disturbed area, and there was no additional surface disturbance. In addition, the modification did not change the cultural distances included on the original Form 2A.
