THE GROUNDWATER PLUME HAS BEEN DELINEATED AND NO FURTHER SUBSURFACE INVESTIGATION IS REQUIRED AT THE SITE. LAB ANALYTICAL RESULTS FROM GROUNDWATER AND SOIL SAMPLES THAT WERE COLLECTED DURING EXCAVATION AND GEOPROBING ACTIVITIES INDICATE THAT MODERATE HYDROCARBON IMPACTS EXIST OUTSIDE THE EXTENT OF THE PREVIOUS EXCAVATION. GROUNDWATER WAS IMPACTED AT THE SITE. AS DESCRIBED IN THE FEBRUARY 27, 2012 FORM 19, THREE TEMPORARY GROUNDWATER MONITORING WELLS WERE INSTALLED AT THE SITE. FOLLOWING AS, SVE, AND CHEMICAL OXIDATION INJECTION ACTIVITIES, THE TEMPORARY MONITORING WELLS WILL BE SAMPLED DURING THE FOLLOWING QUARTERLY MONITORING PERIOD TO DETERMINE RESIDUAL HYDROCARBON IMPACTS IN GROUNDWATER CONTINUE TO PERSIST AT THE SITE USING USEPA METHOD 8260B. SHOULD CONFIRMATION GROUNDWATER SAMPLES INDICATE THAT CONCENTRATIONS ARE BELOW THE COGCC TABLE 910-1 LIMITS FOR HYDROCARBON IMPACTS, PDC WILL MONITOR GROUNDWATER CONCENTRATIONS AT THE SITE UNTIL FOUR CONSECUTIVE QUARTERS OF GROUNDWATER ANALYTICAL RESULTS ARE IN COMPLIANCE WITH COGCC STANDARDS.
