## COMMENTS:

Add six (6) water tanks, fifteen (15) separators, two (2) electric motors, two (2) LACT Units, three (3) gas compressors, sixteen (16) oil tanks, two (2) VRU's, two (2) produced water skids, one (1) condensate tank, and one (1) PDC skid to the location. Therefore, the new totals are twenty-two (22) water tanks, twenty-three (23) separators, two (2) electric motors, two (2) LACT Units, three (3) gas compressors, thirty-two (32) oil tanks, two (2) VRU's, two (2) produced water skids, one (1) condensate tank, and one (1) PDC skid.

The modification of this oil & gas location was within the originally disturbed area, and there was no additional surface disturbance. In addition, the modification did not change the cultural distances included on the original Form 2A.
