Well is to be re-entered to add cement plugs at 4020' to 3620' and Fox Hills coverage from 1540' to 737'. The production casing was internally cemented from 8377' to 4205' in 1993. Purpose is to reenter and adequately replug prior to hydraulic stimulation of proposed horizontal well per DJ Basin Offset Policy dated December 16, 2013.
