Comments First String / Production cement will be > 500 feet above TOG. Distance to nearest well completed in the same formation / permitted or existing well penetrating objective formation was measured to the proposed BR C-24O 43A-24-2-98. Distance to the nearest well Completed in the same formation / permitted or existing well belonging to another operator was measured at 1875' to the Riata Energy - Sulphur Creek Federal 2 (API 05-103-05152).

This well is being proposed from an existing pad on Ursa-owned surface. The proposed well will BHL on federal minerals. Pre-application notifications were not required as all Surface owners within 1000' are Ursa or Federal and there are no building units located within 1000' of the pad location. Ursa will be pursuing Federal APDs for the proposed C-24O wells concurrently with this application.
