GROUNDWATER WAS IMPACTED AT THE SITE. ON APRIL 20, 2012, USING DIRECT PUSH GEOPROBING ACTIVITIES, SEVEN (7) TEMPORARY GROUNDWATER MONITORING WELLS WERE INSTALLED AT THE SITE. THE MONITORING WELLS WERE SAMPLED FOR DISSOLVED PHASE PETROLEUM HYDROCARBON CONCENTRATIONS IN GROUNDWATER USING USEPA METHOD 8260B (BTEX AND NAPHTHALENE). PDC WILL CONTINUE TO SAMPLE THE 7 MONITORING WELLS ON A QUARTERLY BASIS TO ASSESS THE DISSOLVED PHASE PETROLEUM HYDROCARBON IMPACTS IN GROUNDWATER USING USEPA METHOD 8260B.
