File electronic Form 42 once abandonment complete.</p> <p>4) Operator indicated the well has a gyro from December 2014 that has not been submitted to COGCC. Submit gyro survey data with Form 6 Subsequent Report of Abandonment.</p> <p>5) Production casing stub plug is also surface casing shoe plug, this plug must be tagged at 352' or shallower. Leave at least 100' of cement in the wellbore for each plug.</p>
