## COMMENTS:

Add one (1) PDC skid, and one (1) manifold building to the location. Therefore, the new totals are one (1) PDC skid, and one (1) manifold building.

Buried flowlines are utilized to transfer multiphase flow from the wellheads to the production facility. A three (3) inch nominal diameter steel flowline engineered to handle design pressures connect each wellhead to a manifold building. The flowlines continue from the manifold building to the production facility off of the pad. During production, the flow is from the wellhead to the production facility. Individual flowlines that connect the wellheads to the manifold buildings are approximately 300 feet in length. The flowline sections that begin at the manifold buildings and terminate at the production facility are approximately 1200 feet in length.

The modification of this oil & gas location was within the originally disturbed area, and there was no additional surface disturbance. In addition, the modification did not change the cultural distances included on the original Form 2A.
