- Production Csg: 4.5" – 15.1# - Set @ 7,200' w/ 220 sxs
- CBL Production Casing TOC: @ 6,062'
- 2 3/8" 2.9# tubing set at 6,759' (6/28/2013)
- Deepest water well in area: 360'
- NOTE: The Sussex formation is productive in this area and the Mark 11-35 well will need to have the Sussex formation isolated.

- 1) MIRU WO rig.
- 2) Make sure well is dead. Check Bradenhead pressure.
- 3) POOH with tubing.
- 4) ND WH.
- 5) Spear 4.5" production casing to remove out of slips.
- 6) TIH w/ 1 1/4" 3.02# CS Hydril stick pipe to 4,600' in production casing annular space.
- 7) RU cmt unit.
- 8) Mix and pump 200 sxs cement from 4,600' to 4,100' to cover Sussex formation.
- 9) Reset 1 1/4" tubing to 600'.
- 10) Mix and pump 160 sxs cement from 600' to Surface'.
- 11) Top remaining annular volume off.
- 12) Set slips and NU WH. TIH with tubing.
- 13) RDMO WO rig. Return well to production.
