Therefore, the new totals are thirteen (13) separators, one (1) electric motor, one (1) LACT Unit, one (1) gas compressor, eighteen (18) oil tanks, one (1) produced water skid, and two (2) VRU's.

The modification of this oil & gas location was within the originally disturbed area, and there was no additional surface disturbance. In addition, the modification did not change the cultural distances included on the original Form 2A.
