The purpose of this sundry is to request the removal of the COA on the McGlothlin Farms 5N64W4DX pad (API: 05-123-4409) and McGlothlin 5N64W4DX (API: 05-123-43949) pad permits requiring an option 1 or 2 mitigation be done prior to the frac of the aforementioned well pads. A form 5 reporting a remedial cement job done 12/6/2006 has been submitted with doc #401206260. In lieu of option 1 or 2 mediation, PDC requests an option 4 - pull tubing, set RBP, install a 5K wellhead, setup automation and monitor the bradenhead. PDC beleives this will be adequate mediation as there is cement coverage from 5210'- surface. CBL confirming cement coverage is attached.
