Diana,

We are drilling the Kiteley 9. We landed in zone and had been anticipating a downward dip of about 87.5-88 degree (70-90'TVD drop), however upon drilling we have been in the fort Hays for 1500' of the first 2000' of this lateral. Dip is closer to 86 degrees (150' TVD drop), being how this is the first well on the pad we would like to sidetrack and make another attempt at this knowing a little more about the dip.

With your permission, we would like to sidetrack at 9,044' and move our targets down to adjust for increased downward dip.
