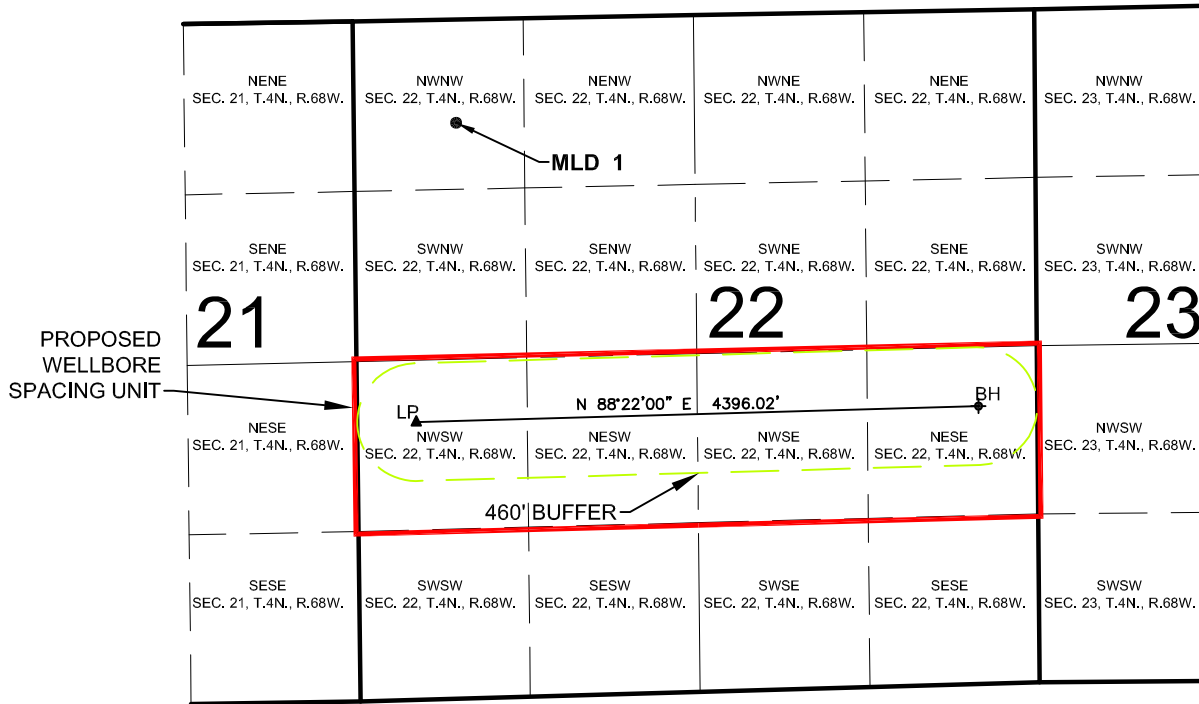

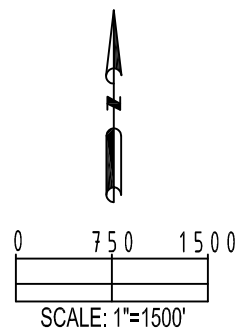
### BOTTOM HOLE LOCATION
