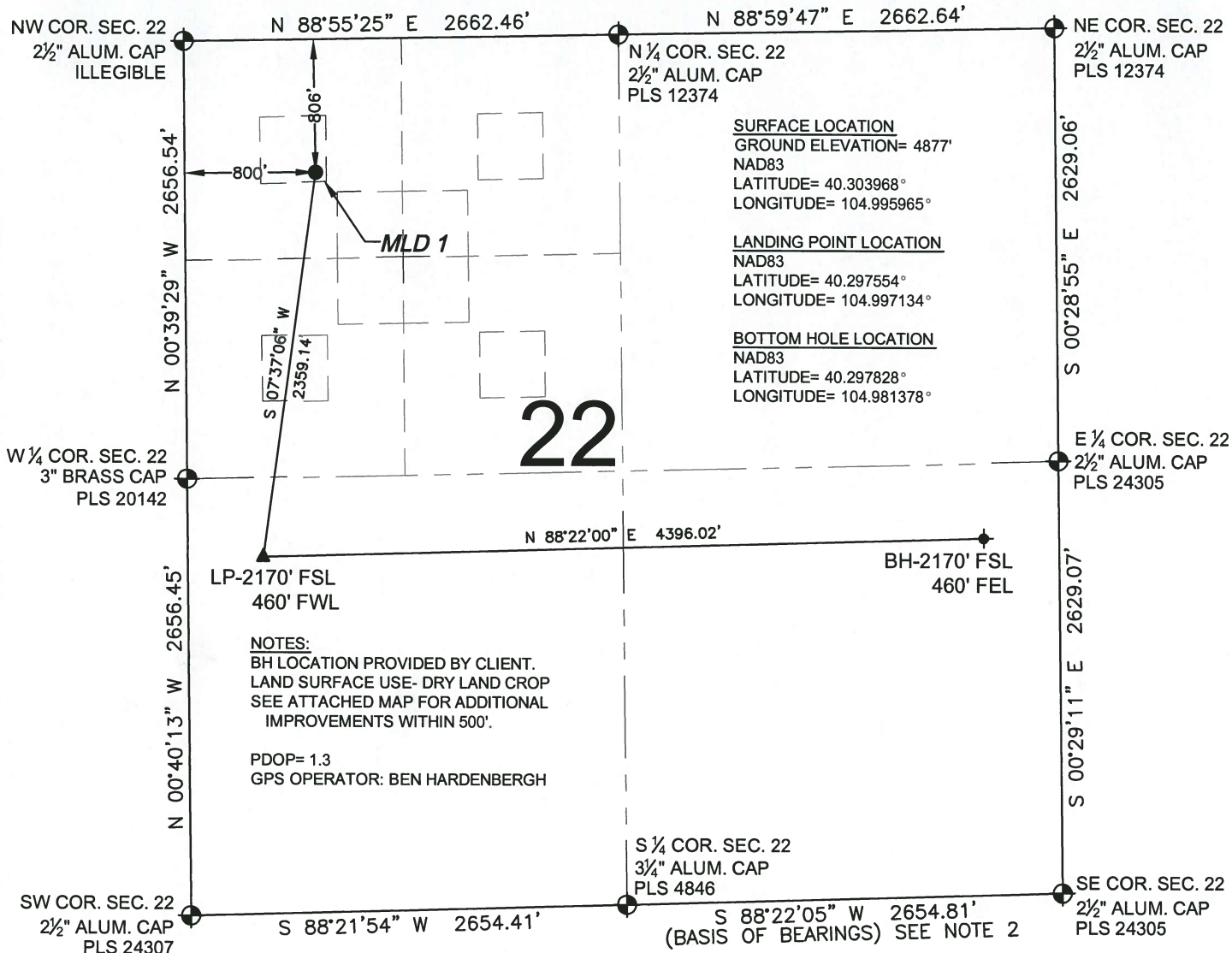


WELL LOCATION CERTIFICATE: MLD 1

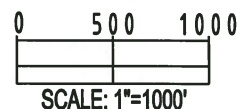
- = EXISTING MONUMENT ▲ = LANDING POINT
