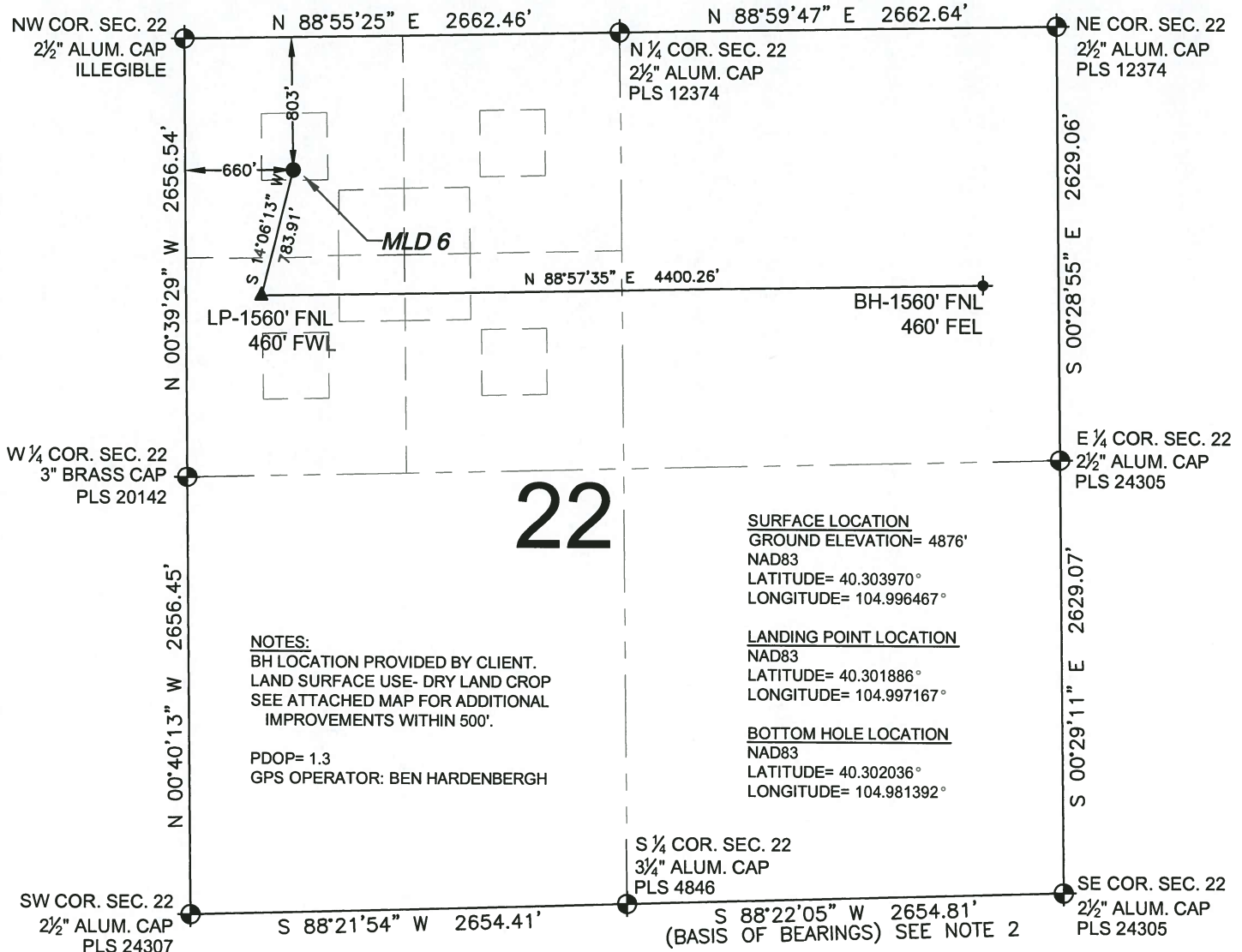


WELL LOCATION CERTIFICATE: MLD 6

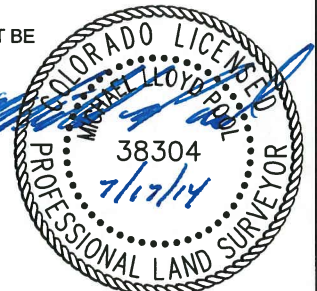
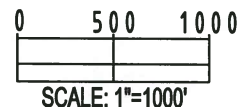
