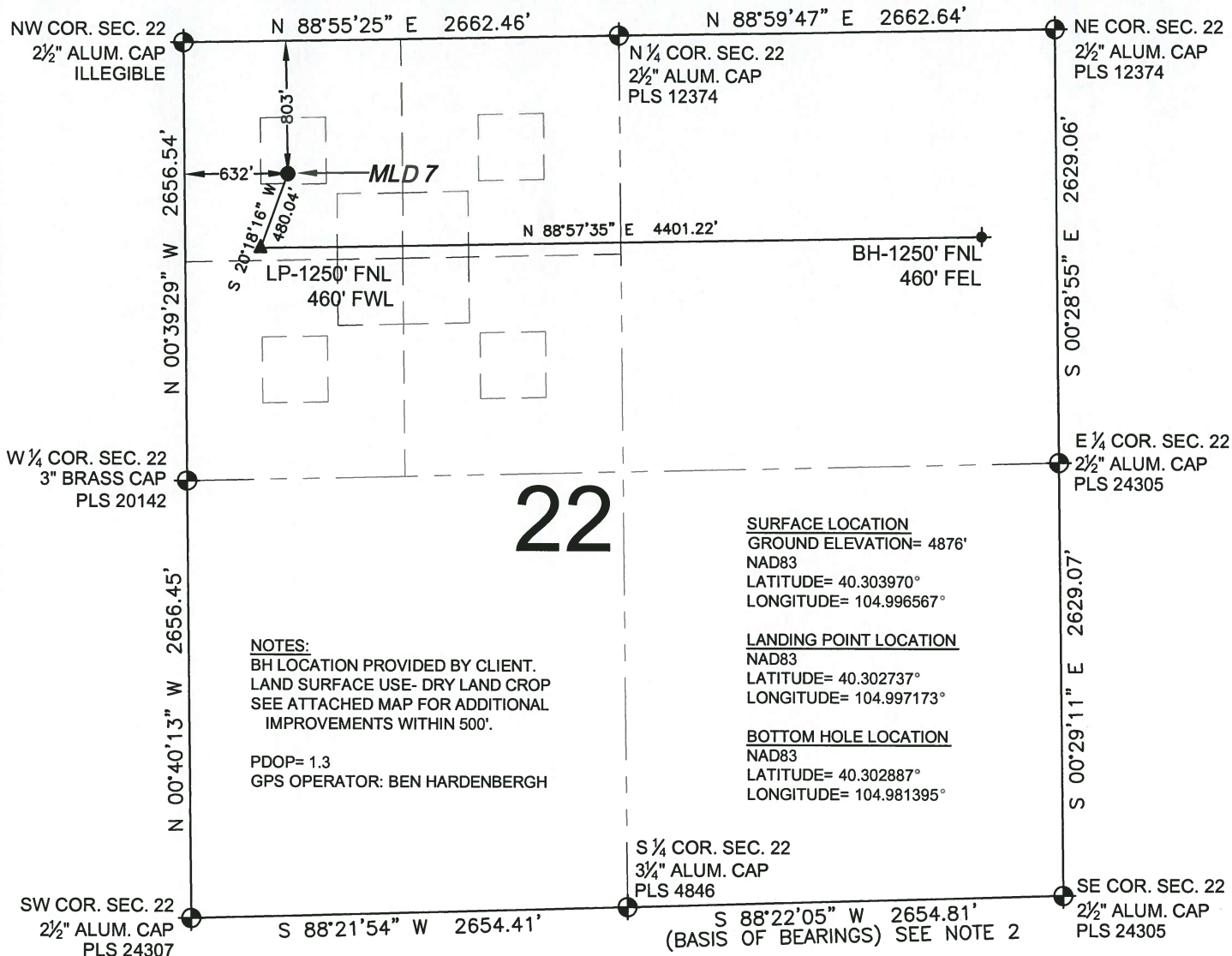


# WELL LOCATION CERTIFICATE: MLD 7

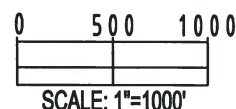
- = EXISTING MONUMENT    ▲ = LANDING POINT
