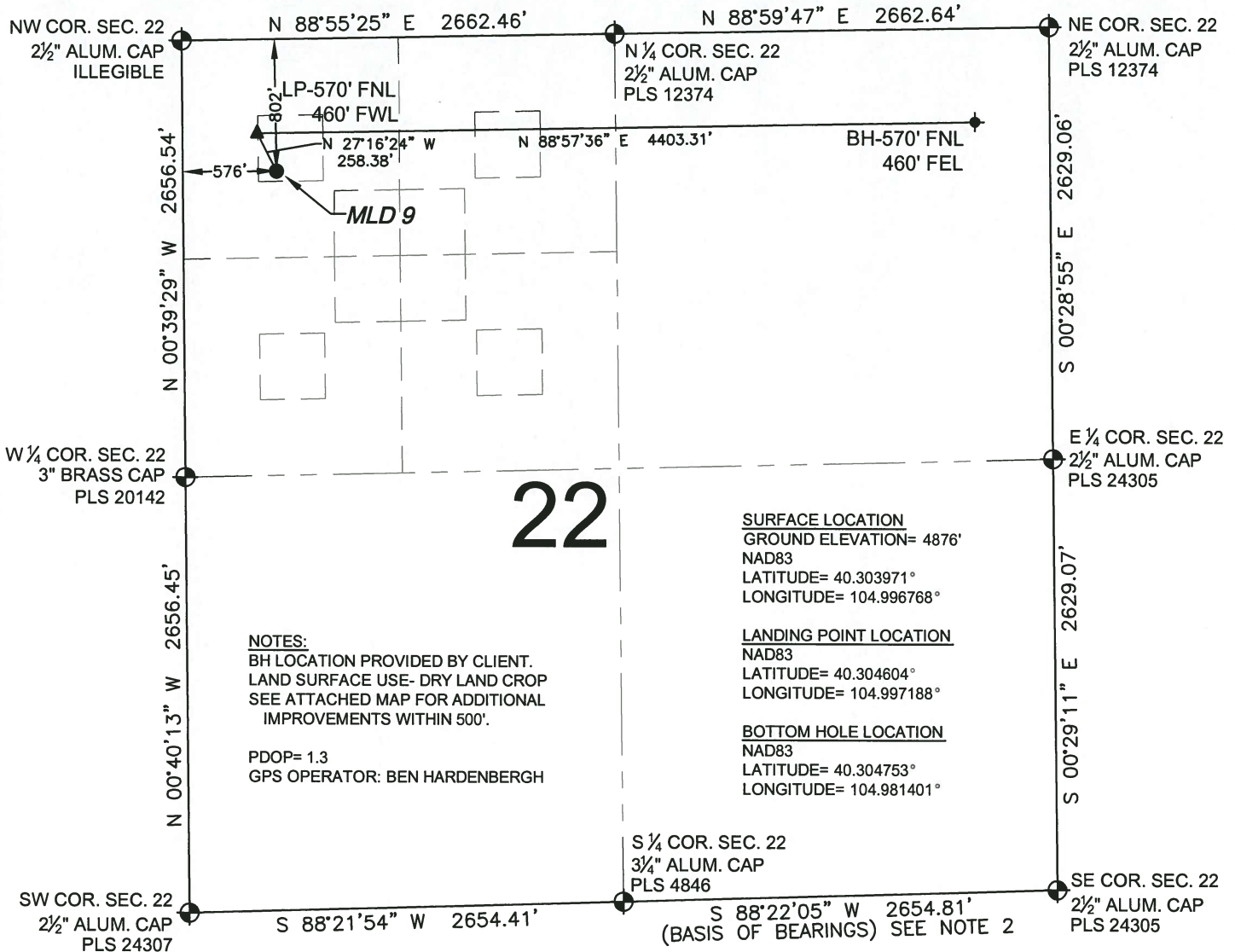


# WELL LOCATION CERTIFICATE: MLD 9

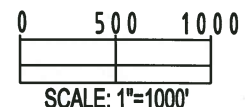
- = EXISTING MONUMENT
