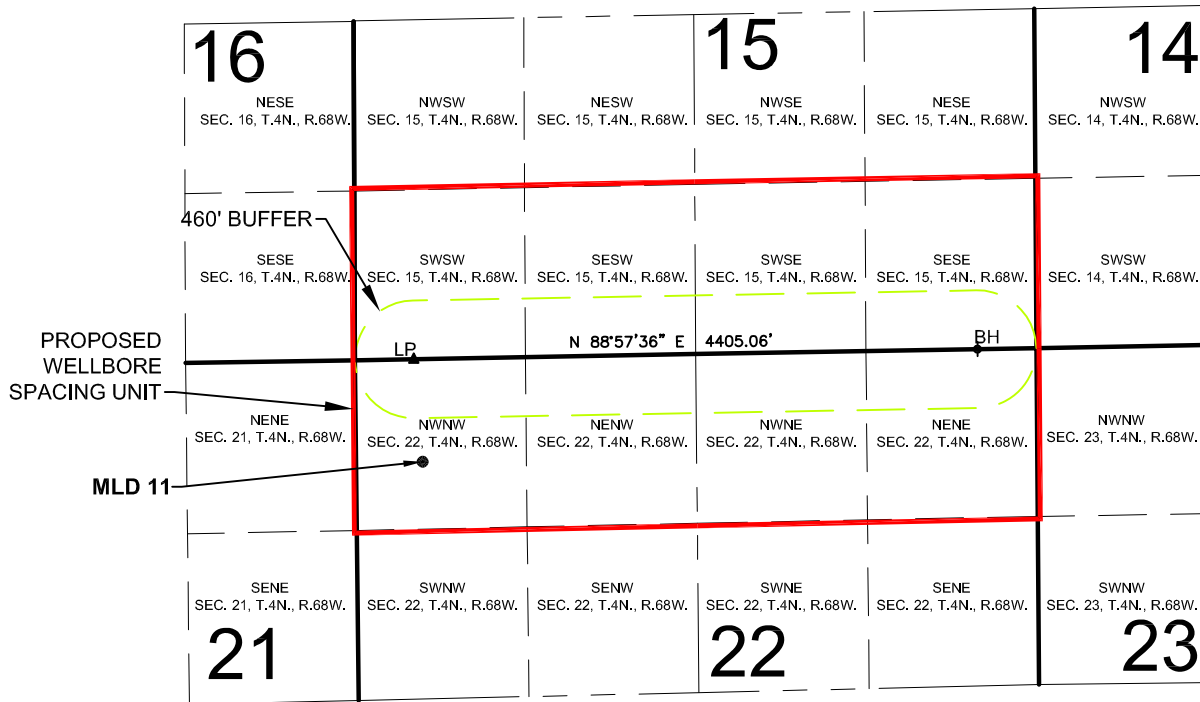

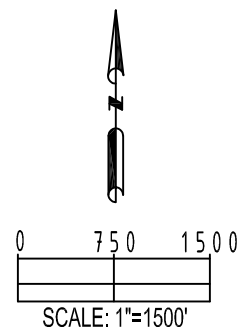
BOTTOM HOLE LOCATION
