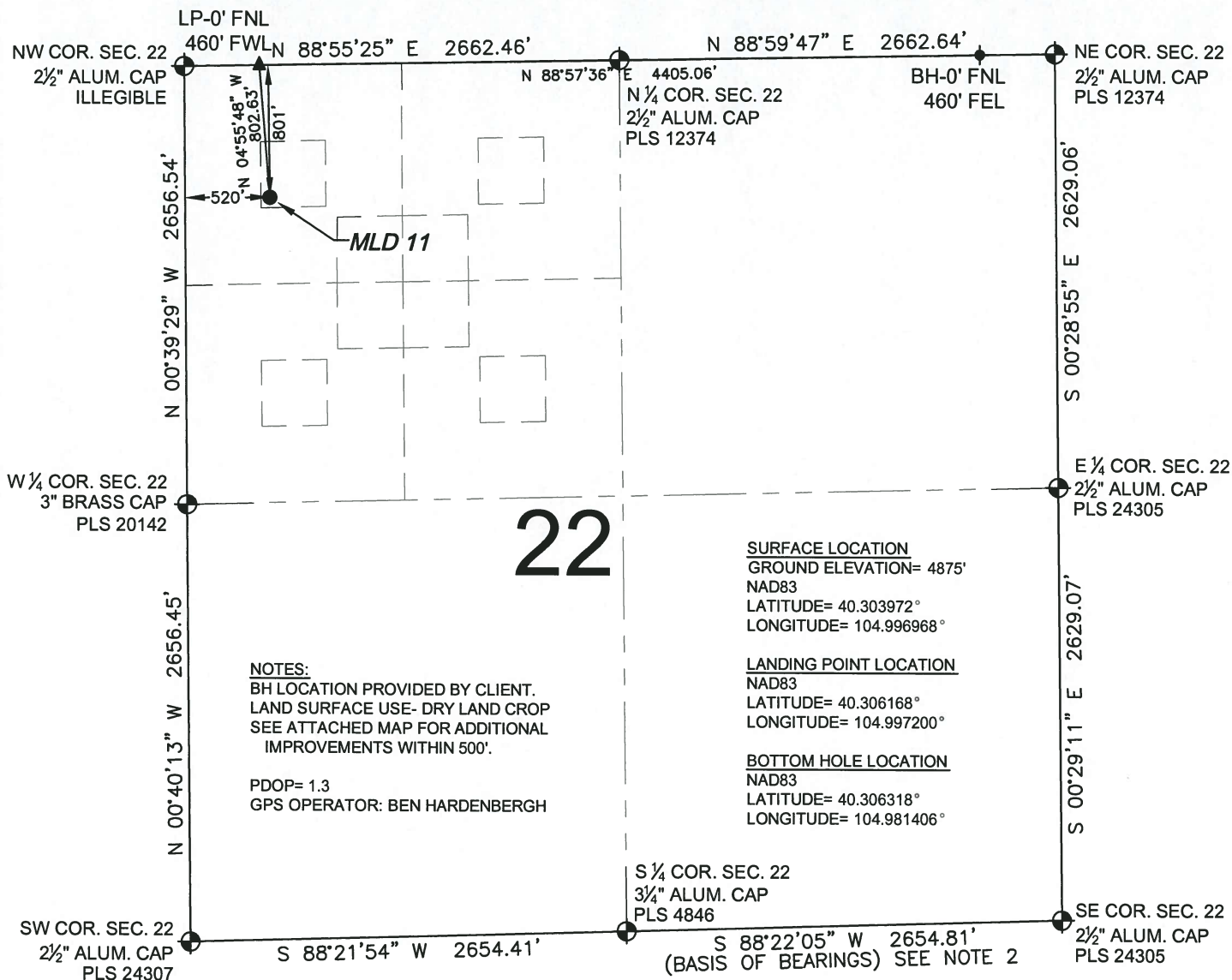


WELL LOCATION CERTIFICATE: MLD 11

LEGEND

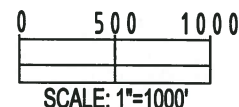
- = EXISTING MONUMENT
