PDC will continue to sample the seven monitoring wells on a quarterly basis to assess the dissolved phase petroleum hydrocarbon impacts in groundwater using USEPA Method 8260. Groundwater sampling will continue until four consecutive quarters of groundwater monitoring data indicate that VOC concentrations are below the Colorado Oil and Gas Conservation Commission (COGCC) Table 910-1 limits for Waste Management.
