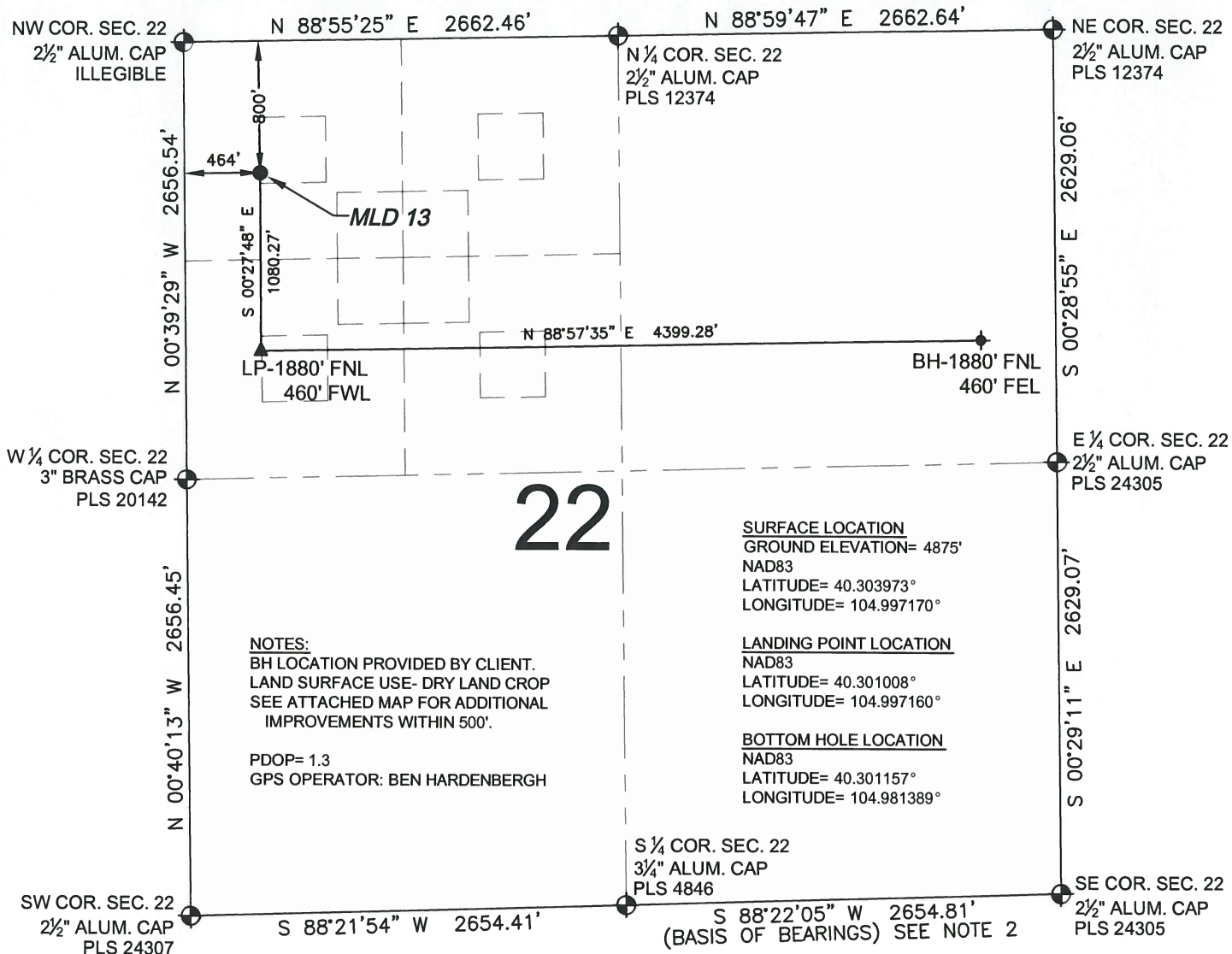


WELL LOCATION CERTIFICATE: MLD 13

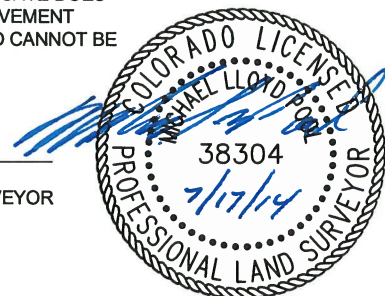
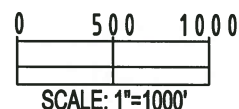
