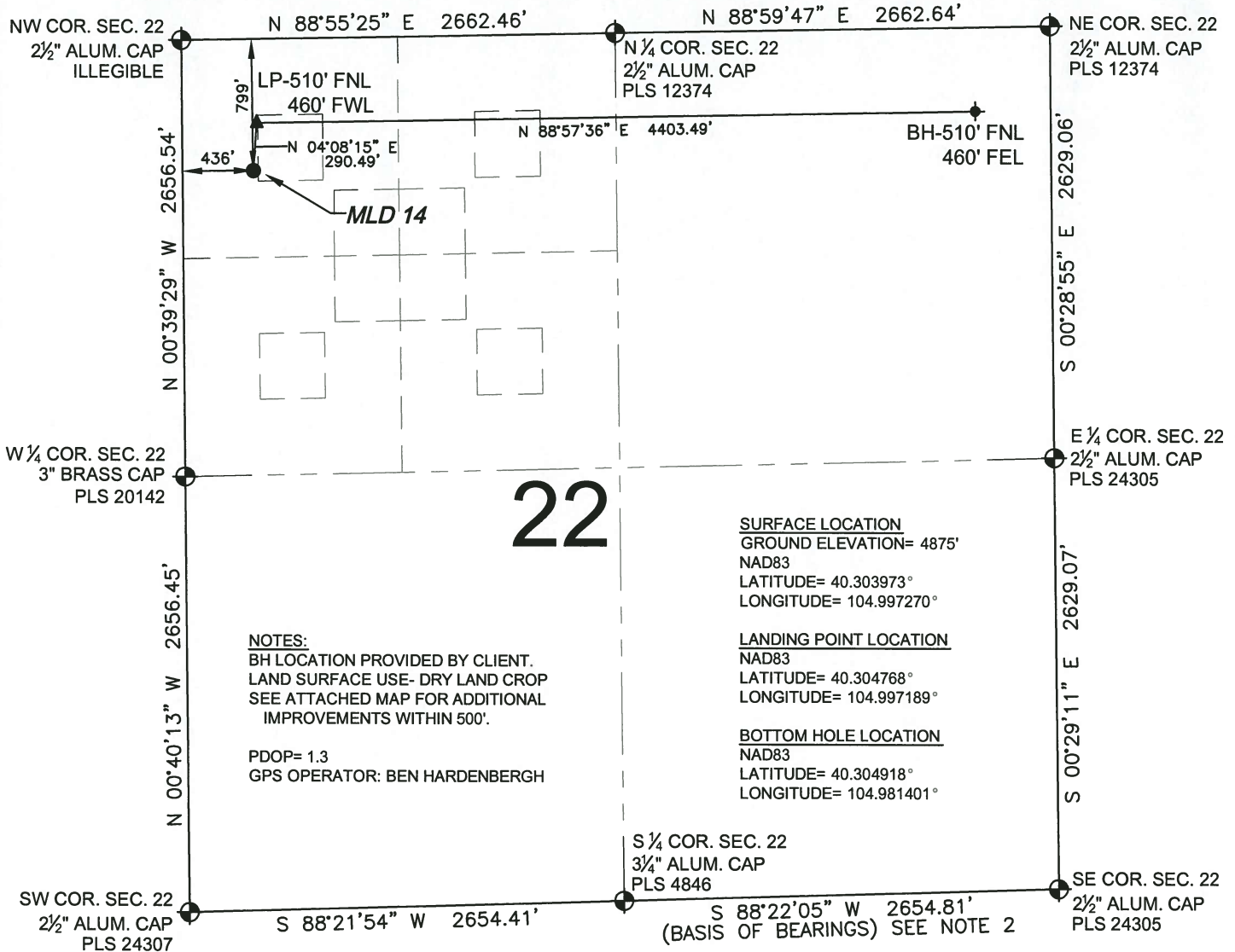


WELL LOCATION CERTIFICATE: MLD 14

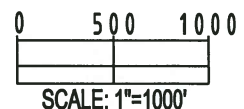
- = EXISTING MONUMENT ▲ = LANDING POINT
