Pioneer Natural Resources is requesting that the Raton Monitor Well 21-29 continue to be a monitor well. This well was drilled as a monitor well in September of 2000 and was never completed as a producing well. It has been monitored periodically since April 2001 as a pressure monitor well. The data obtained from the well is being used in a study to improve the ultimate recovery and economics of the field. On September 1, 2014, approval for a 502 Variance for MITs was given. Document 400440331 is attached for reference as was requested in Document 40440320.
