Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until Final Reclamation has passed. Revegetation activities shall be complete no later than 5/31/2017. Submit a field inspection report resolution (FIRR) form to inspector once CAs have been addressed.
