Pioneer is submitting this 502.b reclamation Waiver for the Axis 31-24 well location located in Las Animas, County Colorado. At this time Pioneer is reporting completion of final reclamation for the well and r-o-w associated with the location. Pioneer has entered into an agreement with the surface owner regarding final reclamation of the well site and r-o-w. The Surface owner has requested that the well pad be left compacted, stabilized and covered with gravel, the intended land use for the well pad is to be utilized as a staging area for hunting and live stock management. Additionally the surface owner requested that the r-o-w remain in place compacted, stabilized and covered with gravel to serve as a ranch road; additionally historical imagery was located from 2005 showing the road to be in existence prior to oil and gas activity on the property.
