Matt,

I have reviewed the referenced Form 2A Oil & Gas Location Assessment and have the following comments.

- 1) In the Location Identification section you have indicated this Oil & Gas Location was surveyed by Robert Kay on 12/10/10. However, the Location Drawing indicates it was re-surveyed by J.C., D.S. on 3/28/16 to add the three proposed oil and gas wells. Therefore, I would like to update the Form 2A to reflect this.
- 2) In the Construction section you have indicated the date planned to commence construction is 4/20/17 and the estimated date that interim reclamation will begin is 4/1/18. This is nearly a year and not in compliance with our Rules regarding interim reclamation (Rule 1003.b.). For Oil & Gas Locations on Rangeland we require interim reclamation to begin no later than six months after construction. Please provide me with a revised date that interim reclamation will begin that complies with Rule 1003.b. and I will update the Form 2A.
- 3) A review of your Location Drawing shows a 500 foot offset from the edge of the disturbance for the new wells. Since you are amending an existing Oil & Gas Location, the 500 foot offset needs to be from both the new and existing disturbance area. Please revise the Location Drawing to show a 500 foot offset from the combined disturbance area being sure to include the distance and direction to any additional visible surface improvements that may fall within this expanded offset.
