## RECLAMATION PLAN

### RECLAMATION PLANNING

Interim reclamation has previously taken place on this well pad. Treated drill cuttings were mixed with clean soil and buried in the pit with an excess of 3' of cover. Pad slopes were reclaimed not to exceed 3:1 slope. Horizontal ripping, stair-stepping, grooving, tracking, or pocketing on slopes were utilized to reduce erosion. Surface roughening was utilized on all areas receiving revegetation. Topsoil was spread over all areas to be revegetated. These areas are identified on the attached drawing. Seed applied by drill was covered by weed-free straw, mulched and crimped. A copy of the seed mix is attached. Monthly inspections for physical signs of compaction alleviation will be conducted by a qualified inspector while conducting stormwater inspections except when the location is in winter exclusion status. The location will be inspected during the growing season by a qualified contractor capable of identifying noxious weeds and selecting and applying the appropriate chemical to eradicate those noxious weeds.
