INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Five test borings were advanced into the groundwater table during a December 2014 Limited Subsurface Investigation. No soil impacts were reported above the groundwater table in any of the five borings. Impacts were detected in two samples beneath the groundwater table, at 18 feet below ground surface (ft-bgs) (GW table is at 14 ft-bgs), but these are understood to be a potential groundwater issue and distinct from soil impacts above the ground water table.

	Soil with impacts above the Table 910-1 Concentration Levels was present at the site but only documented to be present within the saturated zone. BTEX concentrations in ground water have not been detected above the Table 910-1 Concentration Levels. Therefore, based on the information presented, it appears that no further action is necessary at this time and the COGCC approves the closure request. However, should future conditions at the site indicate contaminant concentrations in soils exceeding COGCC standards or if ground water is found to be impacted, then further investigation and/or remediation activities may be required. In addition, the surface area disturbed by the remediation activity shall be reclaimed in accordance with the 1000 Series Reclamation Rules.
