Comment: The desirable vegetation has not established at the location. There is predominately signs of undesirable weed growth (kochia) throughout the location. Documentation indicates that seeding was performed last spring of 2016. There does not appear to be adequate signs of germination. Additional reseeding should be performed before the next growing season to facilitate vegetation establishment. Continue to monitor and manage the location until the final reclamation requirements are achieved.
