Well was originally shut-in for Horizontal Safety Prep. CIBP w/CMT cap @ 7,100 and CIBP w/CMT cap @ 7,030. A mechanical integrity test was performed to ensure integrity of the casing on 02/16/2017. The well will continue to be shut-in for the next 4 to 5 years waiting for an engineering review. T&A status provided via a down-hole plug and surface isolation provided via closed master valve.
