Dear Ms. Stanczyk,

Please accept this letter as a specific request for confidential status of Great Western Operating Company, LLC's ("Great Western") T&M DE #22-038HC well (API No. 05-123-43241) pursuant to C.R.S. 34-60-106(1)(b), Colorado Oil and Gas Conservation Commission ("COGCC") Rule 308C. and the COGCC Staff's Policy for Maintaining Confidentiality of Exploratory and Wildcat Well Information dated February 10, 2010 (COGCC Staff Policy).

C.R.S. 34-60-106(1)(b) and Rule 308C allow operators to seek confidential status of exploratory wells for a period of six (6) months. Further, the COGCC Staff Policy makes it clear that the Commission shall keep certain information for exploratory wells confidential for a period of six (6) months, with the confidentiality determined from the latest to occur of the following: date well reached total depth, date production casing was run, or the date the well was production tested, if production testing occurred within six (6) months of reaching total depth or running production casing. The COGCC Policy also makes it clear that the following information shall be kept confidential for the six (6) month period of time:

- All down-hole, geophysical electric logs (including directional surveys)
- Any geologic reports, core analysis or drill stem tests
- Drilling and Completion Report (Form 5)
- Completed Interval Report (Form 7)

The COGCC Permitting Staff also follows a guideline that wells may be subject to confidential status if they are located at or more than one mile away from "established production" for the target formation. Upon review of the surrounding sections, the T&M DE #22-038HC well is the only well located in Section 15, Township 8 North, Range 66 West, 6th P.M., Weld County,

Colorado that is targeting the Codell formation and each of the wells in the eight (8) surrounding sections are classified as either DA, IJ, TA, PA or AL, with the one producing well in Section 23, Township 8 North, Range 66 West producing from the Lyons formation. *See attached Map and Table.*


