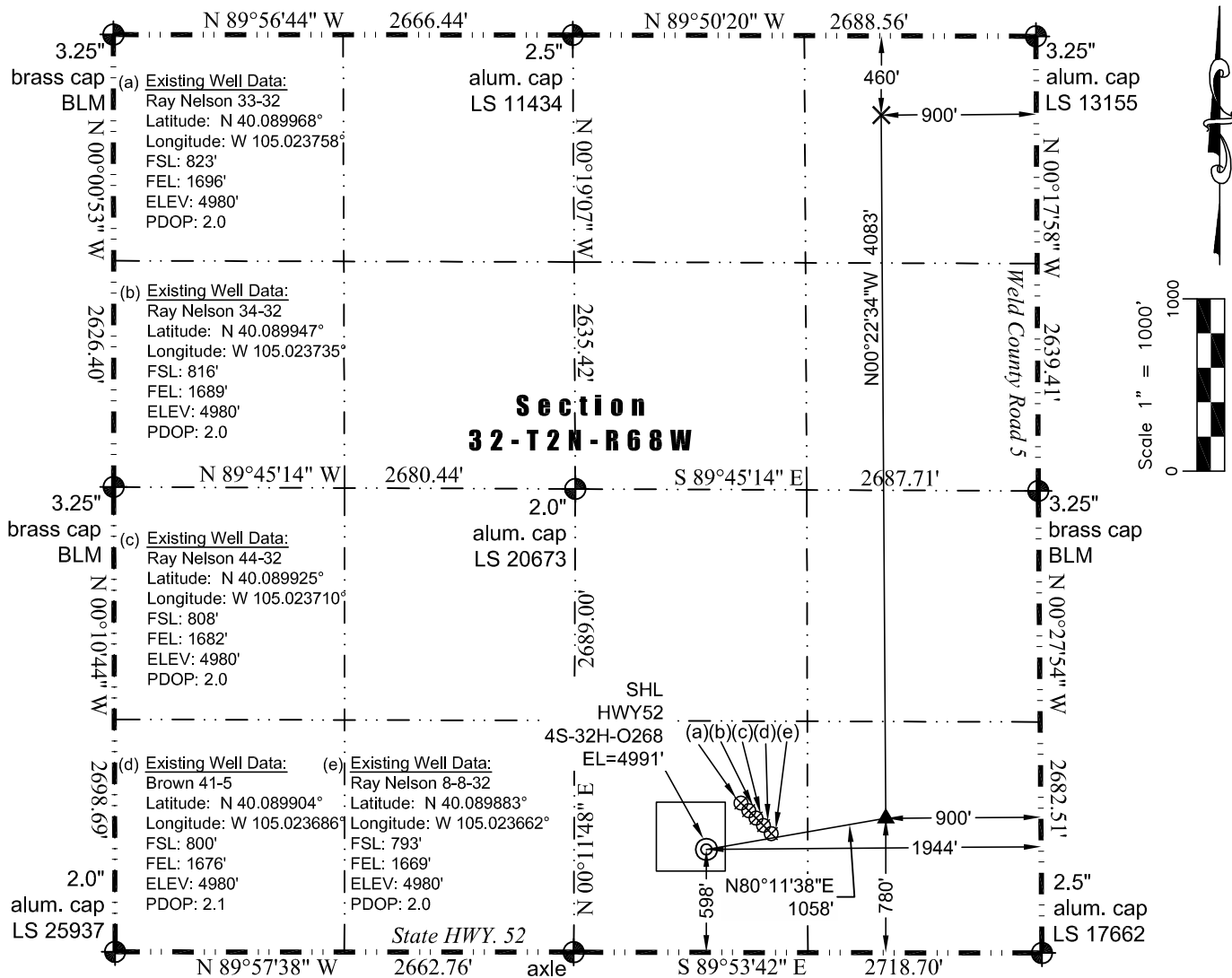




# WELL LOCATION CERTIFICATE

In accordance with a request from Jay Knutson of Crestone Peak Resources, Washburn Land Surveying, LLC has determined the location of the **HWY52 4S-32H-O268** well site to be SHL: 598' FSL and 1944' FEL, (TPZ: 780' FSL and 900' FEL), (BHL: 460' FNL and 900' FEL), as measured at ninety (90) degrees from the section lines of Section 32, Township 2 North, Range 68 West of the 6th Principal Meridian, Weld County Colorado.
