Comment: What appears to be stormwater contaminated water was observed in a puddle around the wellhead. The southern edge of the well pad is not sufficiently stabilized and what appears to be stormwater tunneling into the eroded bank was observed. See attached photos.

Corrective Action: Clean and properly dispose of contaminated water around the wellhead. Stormwater controls are needed to better stabilize the southern edge of the well pad.
