Comments:

The shorter corn observed within the interim reclamation area is due to a later planting timeline than the taller corn crop because a workover rig was on location. The landowner has been compensated for the crop losses this season and documentation is attached. Areas with little to no corn growth was due to inaccessibility to plant because of very wet soil conditions which hindered equipment access. PDC will monitor the area during the next growing season to determine if additional mitigation measures will be required.
