The spacing unit is a 320-acre wellbore spacing unit for the Niobrara and Codell formations.

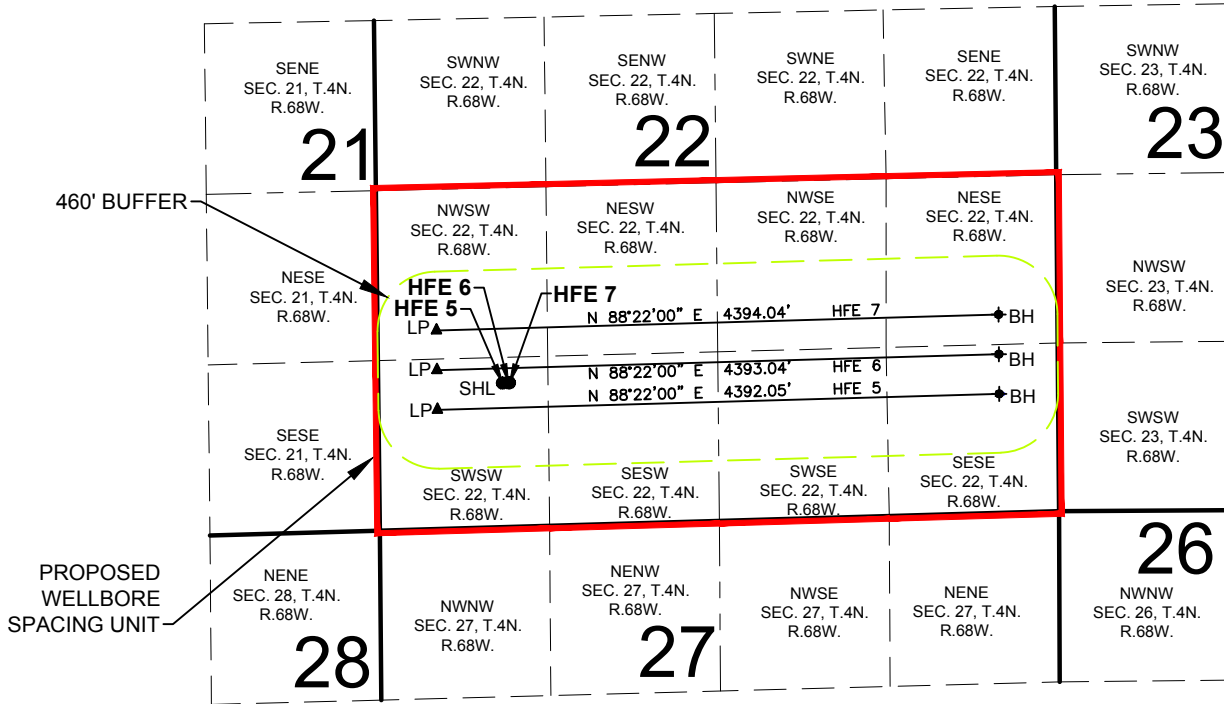

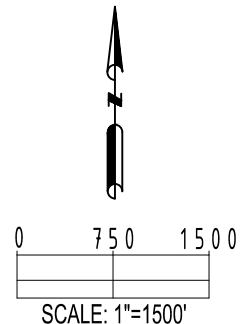
HFE 22-P PAD PROPOSED 318A.a.(4)D SPACING UNIT SEC 22: S2
