3. TIH with CIBP. Set BP at 6471'. Top with 2 sxs 15.8#/gal cement.
4. TIH with tubing. Set tubing at 750'. RU cementing company. Mix and pump 70 sxs 15.8#/gal CI G cement down tubing. Cement should circulate to surface.
5. Cut surface casing 6' below ground level and weld on cap.
