#### COMMENTS:

On March 16, 2017, a step rate test will be conducted on the EWS 4A well using downhole gauges for data recording. The rate steps will be 30 minutes each, and will be approximately 1, 1.5, 2, 2.5, 3, 4, 5.5, 7, 9, 11, 13, and 15 bbl/min. The well will be shut in following the final step, and shut-in pressure will be recorded at 0, 5, 10, and 15 minutes following shut-in. Downhole gauges will collect bottomhole pressure for approximately 1 hour following shut-in before they are pulled from the well.
