4. TIH with CIBP. Set BP at 6446'. Top with 2 sxs 15.8#/gal CI G cement.
5. TIH with casing cutter. Cut 4 1/2" casing at 625'. Pull cut casing.
6. TIH with tubing to 675'. Mix and pump 250 sxs 15.8#/gal CI G cement down tubing. Cement should circulate to surface.
7. Cut surface casing 6' below ground level and weld on cap.

If surface casing plug is not circulated to surface then tag plug – must be at 312' or shallower and provide 10 sx plug at the surface. Leave at least 100' of cement in the casing for each plug.</p> <p>3) Properly abandon flowlines as per Rule 1103. File electronic Form 42 once abandonment complete.</p> <p>4) Prior to starting plugging operations a Bradenhead test shall be performed. If the beginning pressure is greater than 25 psi, or if pressure remains at the conclusion of the test, or if any liquids were present contact COGCC Engineering for sampling requirements. The Form 17 shall be submitted within 10 days of the test.</p>
