Comments This location is being amended to add 8 additional wells and the associated production facilities to the pad. The pad location and size is also being amended to accommodate for the additional wells and facilities. The distances for the pad location were provided from the Critter Creek 573-2412H proposed well. All salable quality gas will be piped to a sales line. No unnecessary or excessive flaring will occur at the subject location. Per rule 316C.c a 48 hour notice will be filed prior to commencement of construction operations with the COGCC via a Form 42. The proposed setback locations for the producing intervals of each wellbore complies with order number 421-79 (Codell) and order number 421-86 (Niobrara). The nearest water well was determined using the COGCC maps and the CDWR permit database. The water well permit number is 145577 with 26' to ground water.
