**Comment:** Silt fence BMP has been repaired and appears to be in proper functioning condition. Two (2) sediment traps were haphazardly installed and do not appear to be in proper functioning condition. Groundwater was encountered at the southwest sediment trap. Operator needs to construct BMPs in such a manner that would not have direct impact to groundwater. Rip rap installed for both inlet and outlet protection has not been installed properly. Appears the rip rap was dumped at location without properly installing the BMP to even be a functioning part of the sediment trap. Unconsolidated soil material dug out from the sediment traps has not been properly compacted. S-Fence BMP has not been properly installed along the western sediment trap.

**Corrective Action:** Install or repair required BMPs per Rule 1002.f. in accordance with good engineering practices.
