## OPERATOR COMMENTS AND SUBMITTAL

Comments

Operations Summary:

Hole depth was 8899'. During a wiper trip hole appeared bridge off and while reaming we cut a second well bore and inadvertently sidetracked at 4800'. First survey at bit depth 4800' (survey depth 4729') showed 0.11° separation from original well in the vertical plane (inclination), and 0.63° in the horizontal plane (azimuth). After a lengthy attempt to re-enter the old well bore it was apparent that wellbore bridged off.

The decision was made to drill ahead per a verbal from David Andrews with COGCC.

SHL and BHL locations remain the same.

No cement plugs were set.

KOP is at 4800'.

No anti-collision potential.

Currently drilling ahead at 8390'.

Will be TD at 9902' and landing casing at 9892'.
