Proposed Procedure:

1. MIRU RU pulling unit. Pull tubing.
2. RU wireline company.
3. TIH with CIBP. Set BP at 6740'. Top with 2 sxs 15.8#/gal CI G cement.
4. TIH with CIBP. Set BP at 6431'. Top with 2 sxs 15.8#/gal CI G cement.
5. TIH with tubing to 3000'. Mix and pump 40 sxs 15.8#/gal CI G cement down tubing.
6. TIH with tubing to 600'. Mix and pump 55 sxs 15.8#/gal CI G cement down tubing. Cement should circulate to surface.
7. Cut surface casing 6' below ground level and weld on cap.
